# Zero tolerance of sexual abuse and sexual harassment; PREA coordinator

**Auditor Overall Determination:** Meets Standard

## **Auditor Discussion**

Policy 18.0 mandates zero tolerance toward all forms of sexual abuse and sexual harassment in facilities it operates directly or under contract. The policy includes sanctions for those found to have participated in prohibited behaviors. The policy includes a description of agency strategies and responses to reduce and prevent sexual abuse and sexual harassment of residents. Policies 18.0 and 18.1 includes definitions of prohibited behaviors regarding sexual abuse and sexual harassment.

The agency employs or designates an upper-level, agency-wide PREA Coordinator. The PREA Coordinator has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards in all of its facilities. The position of the PREA Coordinator in the agency's organizational structure and listed as the Detention Superintendent as verified by the submitted org chart. This was confirmed during an interview with the PREA Coordinator.

The agency has one facility and therefore does not require a designated PREA Compliance Manager.

The facility is in compliance with this standard.

# 115.312 Contracting with other entities for the confinement of residents

Auditor Overall Determination: Meets Standard

## **Auditor Discussion**

The agency has entered into or renewed a contract for the confinement of residents since the last PREA audit. The Atascosa Co. Probation Dept. currently contracts with 8 facilities: Pegasus 1-2, Cameron 3-4. Hays 5-6, Travis 7-8, Garza 9-11, Grayson 12-13, Gulf Coast Trades 14-16, Rockdale 17-19. This was verified by a review of the contracts and an interview with the contract's administrator. All the contracts require contractors to adopt and comply with PREA standards.

The contracts require the agency to monitor the contractor's compliance with PREA standards, this was confirmed by the agency's contract administrator and review of the monitoring documentation of the 8 contracted facilities.

The facility is in compliance with this standard.

# 115.313 Supervision and monitoring

Auditor Overall Determination: Meets Standard

## **Auditor Discussion**

Policy 18.3 and Policy 14.1 requires the facility to develop, document, and make its best efforts to comply on a regular basis with a staffing plan that provides for adequate levels of staffing, and, where applicable, video monitoring, to protect residents against abuse. The facility submitted a Staffing Plan for review. This was verified through interviews with the superintendent. During the Site review, the Auditor observed an appropriate number of staff, contractors, and volunteers present (including security and non-security staff) and staffing patterns during every shift, including in the housing units, in the programming, work, education, other areas, and in areas where sexual abuse is known to be more likely to occur according to the staffing plan. The Auditor observed appropriate staffing ratios in the housing unit during waking hours and sleeping hours to ensure the sexual safety of juveniles during waking and non-waking hours of a minimum staffing ratio of 1:8 during waking hours and 1:16 during sleeping hours. The Auditor observed staffing ratios outside of the housing unit(s) during waking hours and sleeping hours. Staffing ratios were maintained constantly and in every area of the facility. These were not aggregate or building-wide ratios. The Auditor observed the staff's line of sight and assessed whether there are blind spots. The Auditor observed areas where persons confined in the facility are not allowed and determined movement in and

out of that space is monitored to ensure that confined persons never enter those areas. The Auditor observed indirect supervision practices, including camera placement. In addition to observation of camera placement, the Auditor inquired about and observed the monitoring room, including staffing rotation and found them to be satisfactory.

Per the PAQ, the staffing plan is never deviated and always complied with. This was confirmed through an interview with the Superintendent and review of the deviation report submitted. During the Site Review, the Auditor observed appropriate ratios were being met on all shifts.

Policy 18.3 states that the facility is obligated by law, regulation, or judicial consent decree to maintain staffing ratios of a minimum of 1:8 during resident waking hours and 1:16 during resident sleeping hours. The Superintendent confirmed this during an interview.

At least once every year the agency or facility, in collaboration with the agency's PREA Coordinator, reviews the staffing plan to see whether adjustments are needed to: (a) the staffing plan; (b) prevailing staffing patterns; (c) the deployment of monitoring technology; or (d) the allocation of agency or facility resources to commit to the staffing plan to ensure compliance with the staffing plan. This was confirmed through an interview with the PREA Coordinator and review of the approved 2022 Staffing Plan.

Policy 18.3 requires that intermediate-level or higher-level staff conduct unannounced rounds to identify and deter staff sexual abuse and sexual harassment. The facility documents unannounced rounds on the Unannounced Rounds Verification Form, which was reviewed by the Auditor. This was confirmed by staff who conduct unannounced rounds. Per policy, over time the unannounced rounds cover all shifts, and the facility prohibits staff from alerting other staff of the conduct of such rounds. The Auditor interviewed staff who conduct unannounced rounds, and they confirmed this practice. During the Site Review, the Auditor observed unannounced rounds taking place and reviewed the shift logs for verification.

The facility is in compliance with this standard.

# Auditor Overall Determination: Meets Standard Auditor Discussion Policy 18.4 states that the facility does not conduct any cross-gender strip or cross-gender visual body cavity searches of residents. During Site Review, the Auditor did not observe any cross-gender searches and informal conversations with staff and residents confirmed that cross-gender searches are prohibited.

Per Policy, the facility does not permit cross-gender pat down searches of residents, absent exigent circumstances. This was confirmed by random staff and residents during interviews.

The Policy requires that all cross-gender strip searches, cross-gender visual body cavity searches, and cross-gender pat-down searches be documented and justified.

The Policy enables residents to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks (this includes viewing via video camera). Policy requires staff of the opposite gender to announce their presence when entering a resident housing unit/area where residents are likely to be showering, performing bodily functions, or changing clothing. This was confirmed during interviews by residents and random staff. During the site review, the Auditor observed all areas where confined persons may be in a state of undress, such as showering, using the toilet, and/or changing their clothes. All areas were private and single use. The Auditor observed electronic surveillance monitoring areas such as control rooms or other spaces where staff monitor live or recorded video feeds of confined persons and determined that same-gender staff are assigned to monitor video surveillance in areas of undressing. Informal conversations with residents and staff confirm that cross-gender viewing is prohibited. Within the housing areas, the Auditor observed opposite-gender announcements when entering the housing units.

The facility submitted PREA refresher training curriculum and power points to validate this standard. Random staff and residents interviewed confirmed that staff announce their presence and that all residents can shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks (this includes viewing via video camera). During the Site Review, the Auditor observed staff of the opposite gender announcing their presence. The Auditor also observed private showers and other areas where residents can undress. The alert is loud enough for all the confined persons in the housing unit/area to hear. The time between the alert and the staff person's arrival provides enough time for confined persons to cover up before the staff enter the area. The alert is provided in such a manner that confined persons with disabilities (e.g., persons who are Deaf or hard of hearing, Blind or have low vision, or those who are cognitively or functionally disabled (including intellectual, psychiatric, or speech disabilities)) are also properly alerted by staff of the opposite-gender in the housing unit. The alert was loud enough for all of the confined persons in the housing unit/area to hear. The time between the alert and the staff person's arrival provided enough time for confined persons to cover up before the staff enter the area.

Policy 18.4 prohibits staff from searching or physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status. This was confirmed during interviews with random staff. At time of audit, the facility did not have any residents that identified as a transgender or intersex on the facility

roster.

Per PAQ, 100% of all security staff who received training on conducting cross-gender pat-down searches and searches of transgender and intersex residents in a professional and respectful manner, consistent with security needs. The Auditor reviewed the training curriculum and training logs of all employees and verified that staff have received the required training. Random staff interviewed confirmed that training was received.

The facility is in compliance with this standard.

# 115.316

# Residents with disabilities and residents who are limited English proficient

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.5 requires the facility to provide disabled residents equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. The facility provided information for Deaf Interpreter Services that provides Polycom and Vidyo. The facility employs bilingual staff. This was confirmed during an interview with the agency head. At time of audit, the facility did not have any residents with disabilities and who are limited English proficient on the roster. The Auditor reviewed staff training records for validation purposes. All residents have immediate access to interpretation services. During the site review, the Auditor observed PREA information and other materials available throughout the facility in English and Spanish.

Policy 18.5 contains established procedures to provide residents with limited English proficiency equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. The facility provides residents with written materials used for effective communication about PREA with residents with Limited English Proficiency. At time of audit, there were no residents with disabilities or who are limited English proficient on the roster.

Policy 18.5 prohibits use of resident interpreters, resident readers, or other types of resident assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the resident's safety, the performance of first-response duties under §115.364, or the investigation of the resident's allegations. The facility would document the limited circumstances in individual cases where resident interpreters, readers, or other types of resident assistants are used. Interviews with random staff confirmed that information is provided by staff and no other residents. At time of audit, there were no residents

with disabilities or who are limited English proficient on the roster.

The facility is in compliance with this standard.

# 115.317 Hiring and promotion decisions

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.6 prohibits hiring or promoting anyone who may have contact with residents, and prohibits enlisting the services of any contractor who may have contact with residents, who has engaged in sexual abuse in a prison, jail, lockup, community confinement facility, juvenile facility, or other institution (as defined in 42 U.S.C. 1997); has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or has been civilly or administratively adjudicated to have engaged in the activity. This was confirmed through file reviews of staff hired or promoted in the past 12 months.

Policy 18.6 requires the consideration of any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. This was confirmed by an interview with the HR staff.

Policy 18.6 requires that before it hires any new employees who may have contact with residents, it (a) conducts criminal background record checks; (b) consults any child abuse registry maintained by the State or locality in which the employee would work; and (c) consistent with Federal, State, and local law, makes its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse. This was confirmed by an interview with the HR staff and a review of staff files.

Policy 18.6 requires that a criminal background records check be completed, and applicable child abuse registries consulted before enlisting the services of any contractor who may have contact with residents. This was confirmed by an interview with the HR staff and a file review.

Policy 18.6 requires that either criminal background records checks be conducted at least every five years of current employees and contractors who may have contact with residents or that a system is in place for otherwise capturing such information for current employees. This was confirmed by an interview with the HR staff and a review of files.

During an interview with the HR staff, the agency asks all applicants and employees who may have contact with residents directly about previous misconduct in written

application for hiring or promotions and in any interviews or written self-evaluations conducted as part of reviews of current employees. The agency also imposes upon employees a continuing affirmative duty to disclose any such misconduct.

Policy 18.6 states that material omissions regarding such misconduct, or the provision of materially false information, shall be grounds for termination.

The HR staff stated that the agency will provide information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom such employee has applied to work.

The facility is in compliance with this standard.

# 115.318 Upgrades to facilities and technologies

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

The facility has not acquired a new facility or made a substantial expansion or modification to existing facilities since the last PREA audit. This was confirmed by the agency head and the Superintendent during interviews.

The facility has installed or updated a video monitoring system, electronic surveillance system, or other monitoring technology since the last PREA audit. The Auditor reviewed documentation of additional cameras being installed and was able to view camera video and locations. This was confirmed by the agency head and the Superintendent during interviews.

The facility is in compliance with this standard.

# 115.321 Evidence protocol and forensic medical examinations

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

Policy 18.9 and 18.8 explain that the facility is responsible for conducting administrative sexual abuse investigations (including resident-on-resident sexual abuse or staff sexual misconduct). The facility is not responsible for conducting criminal sexual abuse investigations (including resident-on-resident sexual abuse or staff sexual misconduct). The PAQ states that the Jourdanton Police Department conducts criminal sexual abuse investigations. This was verified by interviews with random staff.

The Uniform Evidence Protocol contained in Policy 18.8 was reviewed by the Auditor, and it was determined to be developmentally appropriate for youth. The protocol was adapted from or otherwise based on the most recent edition of the DOJ's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents," or similarly comprehensive and authoritative protocols developed after 2011.

Policy 18.8 states that, the facility offers all residents who experience sexual abuse access to forensic medical examinations, and the facility offers all residents who experience sexual abuse access to forensic medical examinations at an outside facility. Policy 18.8 states that forensic medical examinations are offered without financial cost to the victim. Examinations are conducted by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs) at the Methodist Hospital South This was verified through an interview with a representative from Methodist Hospital South. The facility has not had any sexual abuse allegations that require a forensic medical examination in the past 12 months.

The facility has an MOU with Children's Alliance of South Texas Children's Advocacy Center to provide victim advocacy services to residents. They also provide a hotline to call 24/7. A PREA Booklet for Residents and PREA posters with Children's Alliance of South Texas Children's Advocacy Center contact information was observed during the site review.

If requested by the victim, a qualified victim advocate with Children's Alliance of South Texas Children's Advocacy Center will accompany and support the victim through the forensic medical examination process and investigatory interviews and provide emotional support, crisis intervention, information, and referrals as documented in the MOU. This was verified by review of the MOU. At time of audit, there were no residents who reported a sexual abuse on the roster.

Per the PAQ, the agency is not responsible for investigating criminal allegations of sexual abuse and relies on the Jourdanton Police Department to conduct these investigations. The agency has requested that the responsible agency follow the requirements of paragraphs §115.321 (a) through (e) of the standards. This was confirmed by review of a signed agency agreement.

The facility is in compliance with this standard.

# Policies to ensure referrals of allegations for investigations Auditor Overall Determination: Meets Standard Auditor Discussion Policy 18.9 ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment. This was confirmed by the agency head during the interview and review of an internal investigation report.

There were no allegations either administrative or criminal in the past 12 months.

Policy 18.9 requires allegations of sexual abuse or sexual harassment be referred for investigation to an agency with the legal authority to conduct criminal investigations. This was confirmed by the Auditor during an interview with the investigators. The policy regarding the referral of allegations of sexual abuse or sexual harassment for a criminal investigation is published on the agency website and was verified by the PREA Auditor.

The facility has a written agreement with the Jourdanton Police Department describing the responsibilities of both the agency and the investigating entity.

The facility is in compliance with this standard.

# 115.331 Employee training

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

The agency trains all employees who may have contact with residents on(1) Its zero-tolerance policy for sexual abuse and sexual harassment;(2) How to fulfill their responsibilities under agency sexual abuse and sexual harassment prevention, detection, reporting, and response policies and procedures;(3) Residents' right to be free from sexual abuse and sexual harassment; (4) The right of residents and employees to be free from retaliation for reporting sexual abuse and sexual harassment;(5) The dynamics of sexual abuse and sexual harassment in juvenile facilities;(6) The common reactions of juvenile victims of sexual abuse and sexual harassment; (7) How to detect and respond to signs of threatened and actual sexual abuse and how to distinguish between consensual sexual contact and sexual abuse between residents;(8) How to avoid inappropriate relationships with residents;(9) How to communicate effectively and professionally with residents, including lesbian, gay, bisexual, transgender, intersex, or gender nonconforming residents; and(10) How to comply with relevant laws related to mandatory reporting of sexual abuse to outside authorities;(11) Relevant laws regarding the applicable age of consent. This was verified through review of the facility's training curriculum, Policy 18.10, training curriculum and participant guides, PREA refresher training curriculum, TJJD PREA Curriculum, and the Supervision, Monitoring, and Response curriculum. The training received was confirmed through interviews with random staff and a review of staff training records.

Policy 18.10 and training curriculum confirmed that the training is tailored to the unique needs and attributes and gender of the residents at the facility and was verified through record review.

Between trainings the facility provides employees who may have contact with residents with refresher information about current policies regarding sexual abuse

and harassment. This was evidenced by the staff training records, certification list, and a review of the refresher curriculum.

Policy 18.10 states that the agency documents that employees who may have contact with residents understand the training they have received through employee signature or electronic verification. This was verified through review of staff training files.

The facility is in compliance with this standard.

### 115.332 Volunteer and contractor training

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

Policy 18.0 and the ANE Policy states that all volunteers and contractors who have contact with residents are trained on their responsibilities under the agency's policies and procedures regarding sexual abuse and sexual harassment prevention, detection, and response. Training was verified through interviews with volunteers and contractors and review of training records and volunteer training packet.

The level and type of training provided to contractors is based on the services they provide and the level of contact they have with residents, as identified in the volunteer training packet. All volunteers and contractors who have contact with residents have been notified of the agency's zero-tolerance policy regarding sexual abuse and sexual harassment and informed how to report such incidents. This was verified during interviews with contractors and review of training documents.

The agency maintains documentation confirming that the volunteers and contractors understand the training they have received, as verified by review of training records and signed acknowledgement forms.

The facility is in compliance with this standard.

### 115.333 Resident education

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.10 states that residents receive information at time of intake about the zero-tolerance policy and how to report incidents or suspicions of sexual abuse or sexual harassment. The information is provided in an age-appropriate fashion. This was confirmed during interviews with the intake staff and residents and review of

the PREA video and instructor guide. During the site review observation, for demonstration purposes, staff walked the Auditor through the intake process of residents and how sexual safety information is provided at the point of intake. Intake records were reviewed by the Auditor to verify residents received PREA information at time of intake.

The intake staff and residents interviewed stated that within 10 days of intake, residents are provided comprehensive age-appropriate education regarding their rights to be free from sexual abuse and sexual harassment and to be free from retaliation for reporting such incidents, and regarding agency policies and procedures for responding to such incidents. The Auditor reviewed the PREA video and observed displayed posters throughout the facility to confirm that they contain information about sexual safety.

Per the PAQ, all residents have been educated within 7 days of intake. Policy 18.10 requires that residents who are transferred from one facility to another be educated regarding their rights to be free from sexual abuse and sexual harassment and to be free from retaliation for reporting such incidents, and regarding agency policies and procedures for responding to such incidents to the extent that the policies and procedures of the new facility differ from those of the previous facility. This was verified through interview with the intake staff and file review.

Policy 18.10 requires that Resident PREA education is available in formats accessible to all residents, including those who are limited English proficient; Resident PREA education is available in formats accessible to all residents, including those who are deaf; Resident PREA education is available in formats accessible to all residents, including those who are visually impaired; Resident PREA education is available in formats accessible to all residents, including those who are otherwise disabled; and, Resident PREA education is available in formats accessible to all residents, including those who have limited reading skills. This was confirmed through review of education materials and PREA video.

The agency maintains documentation of resident participation in PREA education sessions. The Auditor verified that signed forms are kept in the resident's record.

The agency ensures that key information about the agency's PREA policies is continuously and readily available or visible through posters, resident handbooks, or other written formats. During the site review, the Auditor observed posted or printed signage throughout the facility (e.g., posters, pamphlets, brochures). Signage included audit notices, how to report sexual abuse and sexual harassment, access to outside victim emotional support services, and other relevant PREA information. The auditor reviewed the information provided on signage and determined it is readable and accessible, consistent, and placed throughout the facility to convey vital sexual safety information specific to the facility. Signage is provided in English and Spanish. The signage text size, formatting, and physical placement accommodates most readers, including those of average height, low vision/visually impaired, or those physically disabled/in a wheelchair, etc. The information provided by the signage is not obscured, unreadable by graffiti, or

missing due to damage. The Auditor observed that the information on the signage is accurate and consistent throughout the facility and the signage is accessible to staff and/or those confined in the facility and other persons who may need the information or services provided. The Auditor observed the placement of other PREA signage posted in areas where staff and persons confined in the facility can read and retain the information being provided. Informal conversations with staff and persons confined in the facility regarding signage throughout the facility confirmed that the information is readable, able to understand, accessible, and accurate. Key PREA information is continuously and readily available and observed throughout the facility. The Auditor also reviewed the Resident Handbook for PREA education information.

The facility is in compliance with this standard.

### 115.334 Specialized training: Investigations

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

Policy 18.10 requires that investigators are trained in conducting sexual abuse investigations in confinement settings. The Auditor reviewed training certificates for investigators. Training was provided by NIC and was a two-hour online course. Investigators interviewed confirmed that they attended investigator training.

Specialized training included techniques for interviewing juvenile sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. Training was provided by NIC and was a two-hour online course. Investigators interviewed confirmed that they attended investigator training.

The agency maintains documentation showing that investigators have completed the required training. The Auditor verified this documentation. The facility has four investigators currently employed who have completed the required training.

The facility is in compliance with this standard.

# 115.335 Specialized training: Medical and mental health care Auditor Overall Determination: Meets Standard Auditor Discussion

Policy 18.10 relates to the training of medical and mental health practitioners who

work regularly in its facilities. The PAQ states that the facility has new staff who are registered to take the specialized PREA training, and they have received the four-hour full PREA training. This was confirmed during interviews with the newly hired medical and mental health staff.

Forensic medical exams are conducted at Methodist Hospital South. This was confirmed during an interview with a representative and the newly hired medical and mental health staff. Staff stated that residents requiring a forensic medical exam would be transported to the hospital.

The agency maintains documentation showing that medical and mental health practitioners have completed the required training and the documentation was reviewed by the Auditor.

Training logs of medical and mental health care practitioners were reviewed, and the Auditor ensured they received the training for employees and contractors/ volunteers (depending on their status) in the referenced standards.

The facility is in compliance with this standard.

### 115.341 Obtaining information from residents

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

Policy 18.11 requires screening (upon admission to a facility or transfer to another facility) for risk of sexual abuse victimization or sexual abusiveness toward other residents. The policy requires that residents be screened for risk of sexual victimization or risk of sexually abusing other residents within 72 hours of their intake. The Policy requires that the resident's risk level be reassessed periodically throughout their confinement. This was confirmed during interviews with the staff responsible for risk screening and random residents. During the Site Review, risk screening staff demonstrated to the Auditor during the site review observation the process taken by the facility to complete the risk screening. The screening process occurs in a setting that ensures as much privacy as possible given the potentially sensitive information that could be discussed. Screening staff ask screening questions in a manner that fosters comfort and elicits responses. Screening staff use an instrument to collect information during the risk screening process. Screening staff affirmatively ask persons confined in the facility about their sexual orientation and gender identity by directly inquiring if they identify as LGBTI (in addition to making a subjective determination about perceived status). The Auditor reviewed files of residents admitted to the facility within the past 12 months and found there to be evidence of appropriate screening within 72 hours. Residents confirmed that they all received a risk screening upon admission to the facility.

The Auditor reviewed the Behavioral Assessment and determined it to be an

objective screening instrument.

Screening staff use additional sources of information to complete the initial risk screening assessment. The Behavioral Assessment attempts to ascertain information about (1) Prior sexual victimization or abusiveness; (2) Any gender nonconforming appearance or manner or identification as lesbian, gay, bisexual, transgender, or intersex, and whether the resident may therefore be vulnerable to sexual abuse; (3) Current charges and offense history; (4) Age; (5) Level of emotional and cognitive development; (6) Physical size and stature; (7) Mental illness or mental disabilities; (8) Intellectual or developmental disabilities; (9) Physical disabilities; (10) The resident's own perception of vulnerability; and (11) Any other specific information about individual residents that may indicate heightened needs for supervision, additional safety precautions, or separation from certain other residents. This was confirmed during an interview with staff responsible for completing the risk screening.

This information is ascertained through conversations with the resident during the intake process and medical and mental health screenings; during classification assessments; and by reviewing court records, case files, facility behavioral records, and other relevant documentation from the resident's files. This was confirmed during an interview with staff responsible for completing the risk screening.

During interview, the PREA Coordinator and staff responsible for risk screening stated that the agency implements appropriate controls on the dissemination within the facility of responses to questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the resident's detriment by staff or other residents. The Auditor observed that risk assessments were kept under double lock with restricted staff access.

The facility is in compliance with this standard.

### 115.342 Placement of residents

**Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

Policy 18.11 states that the facility uses information from the risk screening to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse. This was confirmed during interviews with staff responsible for risk screening, and through review of the classification form.

Policy 18.11 requires that residents at risk of sexual victimization may only be placed in isolation as a last resort if less restrictive measures are inadequate to keep them and other residents safe, and only until an alternative means of keeping all residents safe can be arranged. The policy requires that residents at risk of

sexual victimization who are placed in isolation have access to legally required educational programming, special education services, and daily large-muscle exercise. During the Site Review the Auditor did not observe residents at risk of sexual victimization in isolation. This was verified through file review and in interviews with the superintendent and medical and mental health staff.

Policy 18.11 prohibits placing lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed, or other assignments solely on the basis of such identification or status and prohibits considering lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive. The PREA Coordinator and residents that identified as lesbian, gay, or bisexual confirmed this during interview.

Policy 18.11 states that in deciding whether to assign a transgender or intersex resident to a facility for male or female residents, the agency considers on a case-by-case basis whether a placement would ensure the resident's health and safety. At time of audit, there were no residents that identified as transgender or intersex on the roster.

Staff responsible for completing the risk screening stated that placement and programming assignments for each transgender or intersex resident will be reassessed at least twice each year to review any threats to safety experienced by the resident.

Staff responsible for completing the risk screening stated that a transgender or intersex resident's own views with respect to his or her own safety shall be given serious consideration and transgender and intersex residents shall be given the opportunity to shower separately from other residents.

The facility did not have any current or previous case files to review of residents at risk of sexual victimization who were held in isolation in the past 12 months. This was verified during the Site Review and interviews with residents, the superintendent, and medical and mental health staff.

Policy 18.11 states that if a resident at risk of sexual victimization is held in isolation, the facility affords each such resident a review every 30 days to determine whether there is a continuing need for separation from the general population.

	The facility's pamphlet in English and Spanish, reporting posters in English and

Spanish, and Policy 18.12 describes procedures allowing for multiple internal ways for residents to report privately to agency officials about sexual abuse and sexual harassment; retaliation by other residents or staff for reporting sexual abuse and sexual harassment; and staff neglect or violation of responsibilities that may have contributed to such incidents. Random staff and residents were able to describe the multiple ways to report about sexual abuse and sexual harassment. During the site review observation, the Auditor observed posters, handbooks, and other signage throughout the facility. The Auditor also noticed the Notice of Audit posted. Signage language is clear, easy to understand, and at an appropriate reading level for the persons confined in the facility. Signage is specific to services, such as emotional support services and external reporting, and includes language that clearly details what services are available and for what purposes, and it is provided at an ageappropriate reading level. Signage is provided in English and Spanish and can be translated for the other languages spoken in the facility. The signage text size, formatting, and physical placement accommodates most readers, including those of average height, low vision/visually impaired, or those physically disabled/in a wheelchair, etc. The information provided by the signage is not obscured, unreadable by graffiti, or missing due to damage. The information on the signage is accurate and consistent throughout the facility and is accessible to staff and those confined in the facility and other people who may need the information or services provided. The Auditor observed the placement of the how to report sexual abuse and/or sexual harassment posters (external and internal reporting methods). This poster was posted in any areas frequented by persons confined in the facility, including housing/living units, programming areas, education areas, etc. The Auditor was able to test reporting processes within the facility. The Auditor also observed that all confidential files were kept under double locks. This was confirmed by residents and random staff during interviews.

The facility's pamphlet in English and Spanish, reporting posters in English and Spanish, and Policy 18.12 provides at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency. Per the PAQ, the facility does not detain residents solely for civil immigration purposes. The Auditor observed posters within the facility and was able to test the reporting line for accessibility and ease of use. Residents confirmed that the agency provides at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency.

The facility's pamphlet in English and Spanish, reporting posters in English and Spanish, and Policy 18.12 mandates that staff accept reports of sexual abuse and sexual harassment made verbally, in writing, anonymously and from third parties. Staff are required to document verbal reports, and this was confirmed during interviews with random staff and residents.

Policy 18.12 states that the facility provides residents with access to tools to make written reports of sexual abuse or sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. The Auditor reviewed and tested the anonymous reporting procedure located on the agency's

website. At time of audit, the were no residents who reported sexual abuse on the roster.

Policy 18.12 contains procedures for staff to privately report sexual abuse and sexual harassment of residents. This information is found on the agency's website. Staff are informed of these procedures during training. Random staff confirmed they can privately report sexual abuse and sexual harassment of residents. The Auditor was able to test the online anonymous reporting system procedures.

The facility is in compliance with this standard.

### 115.352 Exhaustion of administrative remedies

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.12 contains administrative procedures for dealing with resident grievances regarding sexual abuse.

Policy 18.12 allows a resident to submit a grievance regarding an allegation of sexual abuse at any time regardless of when the incident is alleged to have occurred. The policy does not require a resident to use an informal grievance process, or otherwise to attempt to resolve with staff, an alleged incident of sexual abuse. Per the PAQ, the grievance procedure is one way for residents to report. They will never be required or allowed to attempt to resolve the allegation with staff or other residents.

Policy 18.12 and Policy 11.1 allows a resident to submit a grievance alleging sexual abuse without submitting it to the staff member who is the subject of the complaint, and the Resident Grievance Procedures requires that a resident grievance alleging sexual abuse not be referred to the staff member who is the subject of the complaint.

Policy 18.12 and Policy 11.1 requires that a decision on the merits of any grievance or portion of a grievance alleging sexual abuse be made within 90 days of the filing of the grievance. At time of audit, there were no residents that reported sexual abuse on the roster.

Policy 18.12 and Policy 11.1 permits third parties, including fellow residents, staff members, family members, attorneys, and outside advocates, to assist residents in filing requests for administrative remedies relating to allegations of sexual abuse, and to file such requests on behalf of residents. The policies require that if the resident declines to have third-party assistance in filing a grievance alleging sexual abuse, the agency documents the resident's decision to decline. The policy allows parents or legal guardians of residents to file a grievance alleging sexual abuse, including appeals, on behalf of such resident, regardless of whether or not the

resident agrees to having the grievance filed on their behalf. During the site review, the Auditor observed third party posting throughout the facility in public locations accessible to family members, advocates, and attorneys. The Auditor was able to test the third-party reporting process and was able to verify that the facility has a process for receiving third-party reports.

Per the PAQ, the agency does not require established procedures for filing an emergency grievance alleging that a resident is subject to a substantial risk of imminent sexual abuse.

Policy 18.12 and Policy 11.1 limits its ability to discipline a resident for filing a grievance alleging sexual abuse to occasions where the agency demonstrates that the resident filed the grievance in bad faith. The PAQ states that in the past 12 months, the facility has not received any resident grievances alleging sexual abuse that resulted in disciplinary action by the agency against the resident for having filed the grievance in bad faith.

The facility is in compliance with this standard.

### 115.353

# Resident access to outside confidential support services and legal representation

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.13 provides residents with access to outside victim advocates for emotional support services related to sexual abuse. The facility provides residents with access to such services by giving residents (by providing, posting, or otherwise making accessible) mailing addresses and telephone numbers (including toll-free hotline numbers where available) for local, State, or national victim advocacy or rape crisis organizations. The facility provides residents with access to such services by enabling reasonable communication between residents and these organizations in as confidential a manner as possible. Random residents confirmed during interviews that victim advocacy information is provided to them. During the Site Review, the Auditor observed victim advocacy contact posters throughout the facility as well as resident brochures. Signage language is clear, easy to understand, and at an appropriate reading level for the persons confined in the facility. Signage includes language that clearly details what services are available and for what purposes and is provided at an age-appropriate reading level. The signage text size, formatting, and physical placement accommodates most readers, including those of average height, low vision/visually impaired, or those physically disabled/in a wheelchair, etc. The information provided by the signage is not obscured, unreadable by graffiti, or missing due to damage. During the site review, the auditor tested access to outside emotional support services. The Auditor also observed how mail moves throughout the facility on a daily basis with legal mail handled as

confidential. The facility does not house residents for immigration purposes. At time of audit, there were no residents who reported sexual abuse on the roster.

Policy 18.13 states that the facility informs residents, prior to giving them access to outside support services, the extent to which such communications will be monitored and informs residents, prior to giving them access to outside support services, of the mandatory reporting rules governing privacy, confidentiality, and/or privilege that apply to disclosures of sexual abuse made to outside victim advocates, including any limits to confidentiality under relevant Federal, State, or local law. Residents are made aware of mandatory reporting requirements at orientation. This was verified through interviews with random residents.

The agency maintains a memorandum of understanding with Children's Alliance of South Texas, Child Advocacy Center, a community service provider that provides residents with emotional support services related to sexual abuse.

Policy 18.13 provides residents with reasonable and confidential access to their attorneys or other legal representation and provides residents with reasonable access to parents or legal guardians. This was confirmed through interviews with the superintendent and random residents.

The facility is in compliance with this standard.

The facility is in compliance with this standard.

# Auditor Overall Determination: Meets Standard Auditor Discussion Policy 18.14 provides a method to receive third-party reports of resident sexual abuse or sexual harassment. The agency publicly distributes information on how to report resident sexual abuse or sexual harassment on behalf of residents. Information is posted on the website and numerous postings, brochures, fact sheets in English and Spanish, community grievance forms, are available in multiple locations throughout the facility. Instructions are on the facility's website and the Auditor was able to test this procedure. This was also confirmed through the site review.

Policy 18.14 requires all staff to report immediately and according to agency policy any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is part of the agency. The Policy requires all staff to report immediately and according to agency policy any retaliation against residents or staff who reported such an incident. The Policy requires all staff to report immediately and according to agency policy any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation. Interviews with random staff confirmed that they understand their responsibilities as a mandatory reporter.

ACJDC Policy 2.0-2.2 requires all staff to comply with any applicable mandatory child abuse reporting laws and was confirmed during interviews with random staff.

Policy 18.14 states that apart from reporting to the designated supervisors or officials and designated State or local service agencies, agency policy prohibits staff from revealing any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation, and other security and management decisions and verified through interviews with random staff.

Medical and mental health practitioners stated during interviews that they are required to report sexual abuse to designated supervisors, as well as to the designated State or local services agency where required by mandatory reporting laws and they are required to inform residents at the initiation of services of their duty to report and the limitations of confidentiality. Medical and Mental Health staff have not reported any sexual abuse allegations for this facility. The Auditor reviewed affirmative duty to disclose forms.

The superintendent stated that upon receiving any allegation of sexual abuse, the facility head or designee promptly reports the allegation to the appropriate agency office and to the alleged victim's parents or legal guardians, unless the facility has official documentation showing the parents or legal guardians should not be notified; if the alleged victim is under the guardianship of the child welfare system, the report will be made to the alleged victim's caseworker instead of the parents or legal guardians; and, if a juvenile court retains jurisdiction over the alleged victim, the facility head or designee will also report the allegation to the juvenile's attorney or other legal representative of record within 14 days of receiving the allegation.

The superintendent stated that the facility reports all allegations of sexual abuse and sexual harassment, including third-party and anonymous reports, to the facility's designated investigators.

Policy 18.15 states that when the agency or facility learns that a resident is subject to a substantial risk of imminent sexual abuse, it takes immediate action to protect the resident. Interviews with the agency head, superintendent, and random staff confirm that there have not been any residents that were subject to a substantial risk of imminent sexual abuse.

The facility is in compliance with this standard.

### 115.363 Reporting to other confinement facilities Auditor Overall Determination: Meets Standard **Auditor Discussion** Policy 18.14 requires that, upon receiving an allegation that a resident was sexually abused while confined at another facility, the head of the facility must notify the head of the facility or appropriate office of the agency or facility where sexual abuse is alleged to have occurred. The policy also requires that the head of the facility notify the appropriate investigative agency. Per the PAQ, the facility has not received any allegations of sexual abuse from other facilities in the past 12 months. Policy 18.14 mentioned above requires that the facility head provides such notification as soon as possible, but no later than 72 hours after receiving the allegation. Policy 18.14 requires the facility to document that it has provided such notification within 72 hours of receiving the allegation. Policy 18.14 requires that allegations received from other agencies or facilities are investigated in accordance with the PREA standards. This was confirmed by the agency head and the superintendent.

the report preserve and protect any crime scene until appropriate steps can be taken to collect any evidence. The policy requires that, if the abuse occurred within a time period that still allows for the collection of physical evidence, the first security staff member to respond to the report request that the alleged victim not take any actions that could destroy physical evidence, including, as appropriate, washing, brushing teeth, changing clothes, urinating, defecating, smoking, drinking, or eating. The policy requires that, if the abuse occurred within a time period that still allows for the collection of physical evidence, the first security staff member to respond to the report ensure that the alleged abuser does not take any actions that could destroy physical evidence, including, as appropriate, washing, brushing teeth, changing clothes, urinating, defecating, smoking, drinking, or eating. This was confirmed in interviews with security staff first responders. At time of audit, there were no residents who reported sexual abuse on the roster.

Policy 18.15 requires that if the first staff responder is not a security staff member, that responder shall be required to request that the alleged victim not take any actions that could destroy physical evidence. Agency policy also requires that if the first staff responder is not a security staff member, that responder shall be required to notify security staff. Security staff and non-security staff interviewed, as well as random staff confirm this provision is accurate.

### 115.367 Agency protection against retaliation

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.16 is to protect all residents and staff who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations from retaliation by other residents or staff. The agency has designated a staff member with monitoring for possible retaliation.

According to the interviews with the agency head, superintendent and the designated staff member charged with monitoring retaliation, the agency will employ multiple protection measures, such as housing changes or transfers for resident victims or abusers, removal of alleged staff or resident abusers from contact with victims, and emotional support services for residents or staff who fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations.

Policy 18.16 states that the facility monitors the conduct or treatment of residents or staff who reported sexual abuse and of residents who were reported to have suffered sexual abuse to see if there are any changes that may suggest possible retaliation by residents or staff. The facility acts promptly to remedy any such retaliation. The facility continues such monitoring beyond 90 days if the initial monitoring indicates a continuing need. The PAQ states that there have been zero incidents of retaliation in the past 12 months. This was confirmed by the superintendent and the designated staff member charged with monitoring retaliation.

In the case of residents, such monitoring shall also include periodic status checks. This was confirmed by the designated staff member charged with monitoring retaliation.

The agency head and the superintendent stated that if any other individual who cooperates with an investigation expresses a fear of retaliation, the agency will take appropriate measures to protect that individual against retaliation.

The facility is in compliance with this standard.

### **115.368** Post-allegation protective custody

**Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

Policies 18.16, 5.4 and 13.0 states that residents who allege to have suffered sexual abuse may only be placed in isolation as a last resort if less restrictive measures are inadequate to keep them and other residents safe, and only until an alternative means of keeping all residents safe can be arranged. The facility policy requires that residents who are placed in isolation because they alleged to have suffered sexual abuse have access to legally required educational programming, special education services, and daily large-muscle exercise. The superintendent and medical and mental health staff stated that isolation is not utilized for residents who have suffered sexual abuse. During the site review, the Auditor did not observe any residents being held in isolation.

The facility is in compliance with this standard.

### 115.371 Criminal and administrative agency investigations

**Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

Policy 18.17 is related to criminal and administrative agency investigations. This was confirmed during an interview with investigative staff. The Auditor reviewed an investigative report for allegations of sexual abuse or sexual harassment.

Where sexual abuse is alleged, the agency uses investigators who have received special training in sexual abuse investigations involving juvenile victims pursuant to § 115.334. This was confirmed by the investigators during the interview.

Interviews with investigative staff confirmed that they are the responsible entity along with Jourdanton Police Department for conducting all investigations into sexual abuse or sexual harassment. Investigators have received special training in sexual abuse investigations involving juvenile victims. Investigators gather and preserve direct and circumstantial evidence, including any available physical and DNA evidence and any available electronic monitoring data; interview alleged victims, suspected perpetrators, and witnesses; and review prior complaints and reports of sexual abuse involving the suspected perpetrator.

Policy 18.17 states that the agency does not terminate an investigation solely because the source of the allegation recants the allegation.

Investigators stated that when the quality of evidence appears to support criminal prosecution, investigators conduct compelled interviews only after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution. The credibility of an alleged victim, suspect, or witness is assessed on an individual basis and is not determined by the person's status as resident or staff. The agency will not require a resident who alleges sexual abuse to

submit to a polygraph examination or other truth-telling device as a condition for proceeding with the investigation of such an allegation. Administrative investigations include an effort to determine whether staff actions or failures to act contributed to the abuse; and is documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings. The Auditor reviewed an investigative file and determined that they comply with this provision. During the site review, the

Investigators stated that the agency does not terminate an investigation solely because the source of the allegation recants the allegation.

Investigators stated that when the quality of evidence appears to support criminal prosecution, the agency will conduct compelled interviews only after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution.

Investigators and a resident who reported sexual abuse confirmed that the credibility of an alleged victim, suspect, or witness is assessed on an individual basis and is not determined by the person's status as resident or staff. No agency shall require a resident who alleges sexual abuse to submit to a polygraph examination or other truth-telling device as a condition for proceeding with the investigation of such an allegation.

Investigators stated that administrative investigations include an effort to determine whether staff actions or failures to act contributed to the abuse; and are documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings. During the Site Review, the Auditor observed that investigation files are maintained in a secure area with the investigative agency. The Auditor reviewed an investigation report.

Investigators stated that criminal investigations are documented in a written report by the Jourdanton Police Department that contains a thorough description of physical, testimonial, and documentary evidence and attaches copies of all documentary evidence where feasible and that substantiated allegations of conduct that appears to be criminal shall be referred for prosecution. The Jourdanton Police Department has not had an investigation referred for prosecution.

Policy 18.17 requires the agency to retain all written reports pertaining to the administrative or criminal investigation of alleged sexual abuse or sexual harassment for as long as the alleged abuser is incarcerated or employed by the agency, plus five years.

Investigators stated that the departure of the alleged abuser or victim from employment or control of the facility or agency shall not provide a basis for terminating an investigation.

The superintendent, PREA Coordinator and investigative staff stated that the facility

cooperates with Jourdanton Police Department and remains informed about the progress of the investigation.

The facility is in compliance with this standard.

### 115.372 Evidentiary standard for administrative investigations

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.17 states that the agency imposes a standard of a preponderance of the evidence or a lower standard of proof for determining whether allegations of sexual abuse or sexual harassment are substantiated. The Auditor reviewed investigation files for proper standard of proof. This was confirmed by the investigator during the interview.

The facility is in compliance with this standard.

### 115.373 Reporting to residents

**Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

Policy 18.17 requires that any resident who alleges that he or she suffered sexual abuse in an agency facility is informed, verbally or in writing, as to whether the allegation has been determined to be substantiated, unsubstantiated, or unfounded following an investigation by the agency. This was confirmed during an interview with the superintendent and the investigator. A completed sexual abuse investigation was reviewed by the Auditor.

Jourdanton Police Department conducts all criminal investigations, and the agency requests the relevant information from the investigative entity in order to inform the resident of the outcome of the investigation. The process is outlined in policy 18.17. There have not been any investigations referred to the Jourdanton Police Department in the past 12 months.

Policy 18.17 states that following a resident's allegation that a staff member has committed sexual abuse against the resident, the agency/facility subsequently informs the resident (unless the agency has determined that the allegation is unfounded) whenever the staff member is no longer posted within the resident's unit; the staff member is no longer employed at the facility; the agency learns that the staff member has been indicted on a charge related to sexual abuse within the facility; or the agency learns that the staff member has been convicted on a charge

related to sexual abuse within the facility. Per the PAQ, there has not been a substantiated or unsubstantiated complaint (i.e., not unfounded) of sexual abuse committed by a staff member against a resident in an agency facility in the past 12 months. At time of audit, there were no residents who reported sexual abuse on the roster. The Auditor reviewed the investigation report and found that to be correct.

Policy 18.17 states that following a resident's allegation that he or she has been sexually abused by another resident in an agency facility, the agency subsequently informs the alleged victim whenever the agency learns that the alleged abuser has been indicted on a charge related to sexual abuse within the facility; or the agency learns that the alleged abuser has been convicted on a charge related to sexual abuse within the facility.

Policy 18.17 states that all notifications to residents described under this standard are documented.

The facility is in compliance with this standard.

### 115.376 Disciplinary sanctions for staff

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.18 states that staff are subject to disciplinary sanctions up to and including termination for violating agency sexual abuse or sexual harassment policies.

In the past 12 months, according to the PAQ, zero staff have violated agency sexual abuse or sexual harassment policies.

Policy 18.18 contain disciplinary sanctions for violations of agency policies relating to sexual abuse or sexual harassment (other than actually engaging in sexual abuse) are commensurate with the nature and circumstances of the acts committed, the staff member's disciplinary history, and the sanctions imposed for comparable offenses by other staff with similar histories. In the past 12 months, there have been no staff from the facility that has been disciplined, short of termination, for violation of agency sexual abuse or sexual harassment policies (other than actually engaging in sexual abuse).

According to Policy 18.17, all terminations for violations of agency sexual abuse or sexual harassment policies, or resignations by staff who would have been terminated if not for their resignation, are reported to law enforcement agencies, unless the activity was clearly not criminal, and to any relevant licensing bodies. The PAQ states that in the past 12 months, no staff from the facility have been reported to law enforcement or licensing boards following their termination (or resignation prior to termination) for violating agency sexual abuse or sexual

harassment policies.

The facility is in compliance with this standard.

### 115.377 Corrective action for contractors and volunteers

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

Policy 18.18 requires that any contractor or volunteer who engages in sexual abuse be reported to law enforcement agencies, unless the activity was clearly not criminal, and to relevant licensing bodies. The policy requires that any contractor or volunteer who engages in sexual abuse be prohibited from contact with residents. Per the PAQ, In the past 12 months, zero contractors or volunteers have been reported to law enforcement agencies and relevant licensing bodies for engaging in sexual abuse of residents.

Policy 18.18 states that the facility takes appropriate remedial measures and considers whether to prohibit further contact with residents in the case of any other violation of agency sexual abuse or sexual harassment policies by a contractor or volunteer. This was confirmed by the superintendent during an interview.

The facility is in compliance with this standard.

### 115.378 Interventions and disciplinary sanctions for residents

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.12 requires that residents are subject to disciplinary sanctions only pursuant to a formal disciplinary process following an administrative finding that the resident engaged in resident-on-resident sexual abuse. Residents are subject to disciplinary sanctions only pursuant to a formal disciplinary process following a criminal finding of guilt for resident-on-resident sexual abuse.

Policy 18.12 states that in the event a disciplinary sanction for resident-on resident sexual abuse results in the isolation of a resident, the facility policy requires that residents in isolation have daily access to large muscle exercise, legally required educational programming, and special education services; in the event a disciplinary sanction for resident-on-resident sexual abuse results in the isolation of a resident, residents in isolation receive daily visits from a medical or mental health care clinician; and in the event a disciplinary sanction for resident-on-resident sexual abuse results in the isolation of a resident, residents in isolation have access

to other programs and work opportunities to the extent possible. As noted in the PAQ and through observation of the facility, the facility does not use isolation. The superintendent confirmed that isolation is never used. Investigation reports were reviewed and determined that appropriate sanctions were imposed.

The superintendent stated that the disciplinary process will consider whether a resident's mental disabilities or mental illness contributed to his or her behavior when determining what type of sanction, if any, should be imposed.

Policy 18.12 states that the facility offers therapy, counseling, or other interventions designed to address and correct the underlying reasons or motivations for abuse. The facility considers whether to require the offending resident to participate in such interventions as a condition of access to any rewards-based behavior management system or other behavior-based incentives. Access to general programming or education is not conditional on participation in such interventions. This was confirmed by medical/MH staff during interviews.

Policy 18.12 states that the agency disciplines residents for sexual conduct with staff only upon finding that the staff member did not consent to such contact.

The facility's policies prohibit disciplinary action for a report of sexual abuse made in good faith based upon a reasonable belief that the alleged conduct occurred, even if an investigation does not establish evidence sufficient to substantiate the allegation.

Policy 18.12 states that the agency prohibits all sexual activity between residents and that the agency deems such activity to constitute sexual abuse only if it determines that the activity is coerced.

The facility is in compliance with this standard.

### 115.381 Medical and mental health screenings; history of sexual abuse

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.19 confirms that all residents at this facility who have disclosed any prior sexual victimization during a screening are offered a follow-up meeting within 14 days of intake with a medical or mental health practitioner. Medical and mental health staff maintain secondary materials (MAYSI-2 and Classification Form) documenting compliance with the above required services. This was verified by the staff responsible for risk screening. At time of audit, there were no residents who disclosed sexual victimization at risk screening.

Policy 18.19 states that all residents who have ever previously perpetrated sexual abuse are offered a follow-up meeting with a mental health practitioner within 14

days of the intake screening. This was verified by the staff responsible for risk screening and review of the MAYSI-2 Summary.

Policy 18.19 requires Information related to sexual victimization or abusiveness that occurred in an institutional setting is strictly limited to medical and mental health practitioners. During the site review the Auditor observed that information related to sexual victimization or abusiveness that occurred in an institutional setting is strictly limited to medical and mental health practitioners.

Policy 18.19 states that medical and mental health practitioners obtain informed consent from residents before reporting information about prior sexual victimization that did not occur in an institutional setting, unless the resident is under the age of 18. This was confirmed during an interview with medical and mental health staff.

The facility is in compliance with this standard.

### 115.382 Access to emergency medical and mental health services

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

According to Policy 18.19 and interviews with medical and mental health staff and a resident who reported sexual abuse, resident victims of sexual abuse receive timely, unimpeded access to emergency medical treatment and crisis intervention services. The nature and scope of such services are determined by medical and mental health practitioners according to their professional judgment. Medical and mental health staff maintain secondary materials (e.g., form, log) documenting the timeliness of emergency medical treatment and crisis intervention services that were provided; the appropriate response by non-health staff in the event health staff are not present at the time the incident is reported; and the provision of appropriate and timely information and services concerning contraception and sexually transmitted infection prophylaxis. At time of audit, there were no residents who reported sexual abuse on the roster.

Security Staff and Non-Security Staff First Responders stated that if no qualified medical or mental health practitioners are on duty at the time a report of recent abuse is made, staff first responders will take preliminary steps to protect the victim pursuant and will immediately notify the appropriate medical and mental health practitioners.

Medical/mental health staff stated that resident victims of sexual abuse while incarcerated are offered off-site timely information about and timely access to emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate.

Medical/mental health staff stated that treatment services are provided to every victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident. This is also contained in Policy 18.19.

The facility is in compliance with this standard.

### 115.383

## Ongoing medical and mental health care for sexual abuse victims and abusers

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.19 states that the facility offers medical and mental health evaluation and, as appropriate, treatment to all residents who have been victimized by sexual abuse.

The evaluation and treatment of such victims shall include, as appropriate, follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from custody, this was confirmed through medical and mental health staff interviews. At time of audit, there were no residents who reported sexual abuse on the roster.

According to medical and mental health staff, the facility will provide such victims with medical and mental health services consistent with the community level of care.

Per the PAQ, female victims of sexual abusive vaginal penetration while incarcerated are offered pregnancy tests.

Medical staff state that if pregnancy results from sexual abuse while incarcerated, victims receive timely and comprehensive information about, and timely access to, all lawful pregnancy-related medical services.

Policy 18.19 states that resident victims of sexual abuse while incarcerated are offered tests for sexually transmitted infections as medically appropriate.

Policy 18.19 states that treatment services are provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

Policy 18.19 states that the facility attempts to conduct a mental health evaluation of all known resident-on-resident abusers within 60 days of learning of such abuse history and offers treatment when deemed appropriate by mental health practitioners through referrals and assessments. This was corroborated by medical and mental health staff during the interviews.

### 115.386 Sexual abuse incident reviews

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.17 and the SAIR Form confirms that the facility conducts a sexual abuse incident review at the conclusion of every criminal or administrative sexual abuse investigation unless the allegation has been determined to be unfounded. In the past 12 months there have not been any criminal or administrative investigations of alleged sexual abuse completed.

Policy 18.17 states that the facility ordinarily conducts a sexual abuse incident review within 30 days of the conclusion of the criminal or administrative sexual abuse investigation.

According to the superintendent and Policy 18.17, the sexual abuse incident review team includes upper-level management officials and allows for input from line supervisors, investigators, and medical or mental health practitioners.

Policy 18.17 requires that the facility prepare a report of its findings from sexual abuse incident reviews, including any recommendations for improvement, and submit such a report to the facility head and PREA coordinator. This was confirmed through interviews with the superintendent, PREA coordinator, and members of the incident review team.

Policy 18.17 states that the facility implements recommendations for improvement or documents its reasons for not doing so. The Auditor verified this by reviewing the SAIR Form.

The facility is in compliance with this standard.

### 115.387 Data collection

**Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

Policy 18.20 states that the agency collects accurate, uniform data for every allegation of sexual abuse at facilities under its direct control using a standardized instrument and set of definitions.

Policy 18.20 states that the agency aggregates incident-based sexual abuse data at least annually. A sample of aggregated data was reviewed on the agency's website.

Policy 18.20 states that a standardized instrument includes, at a minimum, the data necessary to answer all questions from the most recent version of the Survey of Sexual Violence (SSV) conducted by the Department of Justice.

Policy 18.20 requires that the agency maintains, reviews, and collects data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews.

Policy 18.20 states that the agency obtains incident-based and aggregated data from every private facility with which it contracts for the confinement of its residents.

The agency has not been requested to provide the Department of Justice (DOJ) with data from the previous calendar year upon request.

The facility is in compliance with this standard.

### 115.388 Data review for corrective action

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Policy 18.20 states that the agency reviews data collected and aggregated in order to assess and improve the effectiveness of its sexual abuse prevention, detection, response policies, and training, including identifying problem areas; taking corrective action on an ongoing basis; and preparing an annual report of its findings from its data review and any corrective actions for each facility, as well as the agency as a whole. This was verified through a review of the facility's annual reports located on the agency's website and interviews with the agency head and PREA Coordinator.

The PREA Annual Report includes a comparison of the current year's data and corrective actions with those from prior years. The Auditor reviewed annual reports of findings from data reviews and corrective actions.

The agency makes its annual report readily available to the public at least annually through its website. The Auditor confirmed this through a review of the agency's website and an interview with the agency head. The annual reports are approved by the agency head, which was also confirmed by the agency head during an interview. The website address is atascosacounty.texas.gov.

The PREA Coordinator stated that when the agency redacts material from an annual report for publication, the redactions are limited to specific materials where publication would present a clear and specific threat to the safety and security of the facility and that the agency indicates the nature of material redacted. The Auditor reviewed previous annual reports and found them to meet this provision.
