

**Resolution of the Board to Set Tax Rate
For the Lytle Independent School District
For the Tax Year 2021**

Date: 9/20/2021

On this date, we, the Board of Trustees of the Lytle Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2021 at a total tax rate of \$1.284864, to be assessed and collected by the duly specified assessor and collector as follows:

\$.964200 for the purpose of maintenance and operations, and

\$.320664 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE DUE TO THE INCREASE IN PROPERTY VALUE.

Comparison of Total Tax Rate for Years 2020 and 2021

2020 = \$1.36

2021 = \$1.28

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 1.04 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$-90.00.
